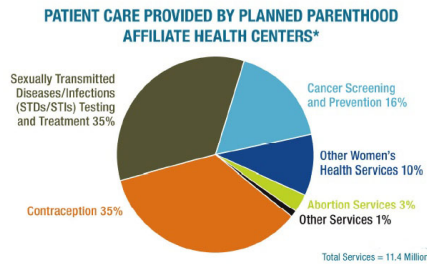
They should be ashamed of themselves!
